Tuition & Payment Options

To best serve our families and simplify billing, ACES offers two payment tracks for the 2026–2027 academic year. Enrollment is limited and processed first-come, first-served.

Payment secures your spot.

Registration Fee

A non-refundable \$35 annual enrollment fee is required per child at registration. This fee is per child and not discounted for siblings. The fee is waived for families who either:

- Pay the full Fall semester tuition by June 18, or
- Register and pay the August monthly tuition by June 18

Registrations completed after June 18 require the \$35 registration fee.

Option 1: Pay by Semester (Preferred – Includes Savings)

Full payment is due by **June 18**.

- **Fall 2026 (August – December):** 1,630 (Saves 195 compared to monthly payments)
 - **Spring 2027 (January – May):** \$1,775
-

Option 2: Pay Monthly

- **\$365 per month** for 10 months (August through May)
- Payments are due on third school day each month
 - No tuition is billed for June or July

Late Payment Fee: \$15 plus \$1 for each day after due date

Returned Payment Fee: \$25

Accounts more than 30 days past due may result in loss of enrollment.

Discounts

Sibling Discount (applies to tuition only, not registration fee)

- Monthly plan: \$10 off per month for each additional child
- Semester plan: \$50 off the semester total for each additional child

To add or remove a sibling mid-year: Written notice must be received by the 15th of the month to take effect the following month.

Cancellation & Withdrawal Policy

We understand that schedules change. To withdraw your child from the ACES program:

- **Written notice required** – Email infoACES4Kids@gmail.com. Verbal requests will not be accepted.
- **Deadline** – Cancellation requests must be received by the **15th of the current month** to avoid billing for the following month.
Example: Cancel by October 15 to avoid November charges.
- **No mid-month prorating** – If notice is received after the 15th, tuition for the next full month will be charged.

Semester Plan Refunds

If you paid the discounted semester rate but withdraw early, the semester discount will be forfeited. Tuition will be recalculated at the standard \$365/month rate for the months attended. Refunds are processed within 30 days of the withdrawal effective date.

Refund Examples

- **Fall withdrawal:** Withdraw effective end of October (notice by Oct 15). Attended Aug, Sep, Oct (3 months \times 365=365=1,095). Refund = 1,630 paid–1,095 = **\$535**
- **Spring withdrawal:** Withdraw effective end of February (notice by Feb 15). Attended Jan, Feb (2 months \times 365=365=730). Refund = 1,775 paid–730 = **\$1,045**

General Payment Policies

Absences & Closures

Tuition is based on the total instructional days in the 2026–2027 Round Rock ISD school year. We do not offer prorated rates, refunds, or credits for:

- Sick days
- Personal absences
- Scheduled district holidays or closures

Program Changes by ACES

ACES reserves the right to modify or cancel the program. In the event of program cancellation by ACES, families will receive a prorated refund for any unused tuition.
